**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**In-Furrow Applications:** At planting, apply **VENERATE™ XC** as an in-furrow spray or as a 5-7 inch band (T-band) over an open furrow at the rate of 3.7 – 7.4 fluid ounces per 1000 feet of row, according to the chart below. Apply **VENERATE™ XC** in 5–20 gallons of water per acre so as the spray is directed over the seed furrow just before the seeds are covered.
